### Background

The site is owned by Hertfordshire County Council and comprised a primary school that closed some years ago. The County Council has since secured Planning Permission (see Town Planning) for the redevelopment of the site for a 75-bed care home (the care home will remain in the ownership of the Council) together with a residential development of up to 70 units.

The Council has demolished all previous structures and has let a build contract for delivery of the care home. The residential site is therefore available for sale. The disposal site comprises an 'irregular' shaped site of approximately 2.384 hectares (5.89 acres). The site is located adjacent to Oxhey Woods, an area of ancient woodland, falls within the Green Belt and is approximately 1km from Carpenders Park Station.

### **Town Planning**

On the 27th October 2021 Three Rivers District Council granted Outline Planning Permission for Development of up to 70 residential dwellings (Use Class C3) with new access from Gosforth Lane (appearance, landscaping, layout and scale reserved). Full details of the permission can be found via the following link; <a href="www3.threerivers.gov.uk/online-applications/">www3.threerivers.gov.uk/online-applications/</a> (search under the planning reference or street name 'Gosforth Lane'). That planning permission includes a reduced affordable housing provision of 26% (70% Social Rented and 30% Shared Equity Tenures).

The 75-bed care home is being delivered via planning permission reference no. 20/1677/FUL. Kori Construction Ltd are now on site having commenced development of the care home. Completion of the care home is due by February 2025. It should be noted that the care home project includes a number of works which benefit the residential site, including off-site highway works, site levelling across the whole site, drainage works, provision of part of the spine road and mains services within the spine road.
